## Candidate Biographical Details / Sonraí Beathaisnéise an Iarrthóra

After studying psychology at University College Dublin, I trained as a clinical psychologist at Trinity College Dublin, where I later completed a PhD in psychiatric genetics. I worked as a lecturer and associate professor in the School of Medicine at Trinity from 2006 until 2013, when I moved to the University of Galway as an established professor in the School of Psychology.

In addition to other undergraduate and postgraduate teaching responsibilities, I established the MSc in Clinical Neuroscience in 2016. I led a HRB-funded Collaborative Doctoral Program from 2018-2023 with colleagues in RCSI, UCD and the University of Galway. Within the School of Psychology I served as director of research from 2013-2023. In 2015, I founded NICOG, the Center for Neuroimaging, Cognition and Genetics with colleagues from Science and Medicine.

My research focuses on understanding the causes of major mental health disorders and developing novel therapeutic programs for treating these. I have authored/co-authored over 300 peer-reviewed articles. In 2016, I received a European Research Council fellowship award for my work on immune function in schizophrenia. In 2020, I received a HRB Research Leaders Award focused on youth mental health. I was elected to the Royal Irish Academy in 2022.
