Entry Details

- All students working on the colouring competition must be registered pupils in a Primary School, which previously participated in the ELEVATE project.
- All entrants work must be their own but may receive support by a teacher.
- Each entry must enclose an entry form.
- Pupils must have permission to participate in the competition. It is the responsibility of all participating schools to give permission for their student to participate in the competition and oversee their participation herein. A teacher/principal must sign the entry form for the best picture of the junior and senior competition to validate permission for all participants.
- The ELEVATE team and all involving parties are not accountable in any form for costs, expenses, damages, liability or injury occurring out of or in any way linked with the competition.
- Not accepted are submissions from groups of individuals. This competition allows work accomplished by individuals only.
- Submitting the entry form and picture will be understood as acceptance of the terms and conditions of the colouring competition.
- The ELEVATE team is not obliged to inform unsuccessful entrants and return unsuccessful submissions.
- Successful entries have to be A4 size and no larger or smaller pictures will be accepted.
- Closing date for the completion is Friday, 7th of April 2017.
- The winners of the, Special needs, junior and senior competition categories and schools will be announced on our project website www.nuigalway.ie/elevate website at the end of May 2017. Additionally, winners will be informed via email/post.
- Submissions will be judged by the EPA in three categories, a special needs category, a junior category (junior infants to 2nd class) and a senior category (3rd -6th class).
- Overall three individual winners will be selected, one from the special needs category, one from the junior category and one from the senior category.
- Prizes are:
 - Winning entries will be published on the ELEVATE website and possibly on the EPA website.
 - The winner of the special needs competition will receive a prize of €50
 - The winner of the junior competition will receive a prize of €50
 - The winner of the senior competition will receive a prize of €50
 - The school of the winning entrants will receive €200 each
 - The winning entries may be recreated and amended/edited if needed to be displayed and printed on the website and future projects.

Rules & Regulations

- No correspondence will be entered into regarding the judging process and the decision of the EPA judges will be final. The adjudication process will be carried out by the ELEVATE team and the EPA and all decisions are final.
- The ELEVATE team and EPA and those working for or on behalf will not be responsible for lost, late, misdirect, damaged, submissions or attempted submissions.
- Employees, contractors or persons directly or professionally associated with employees of the ELEVATE team or EPA may not compete in this competition.
- It is imperative that all entries must be the pupils' original work and not plagiarised wholly or in part.
- By entering the Reducing Pollution in our Environment with ELEVATE Competition you agree that the ELEVATE team and EPA and all connected parties has the right to include entrants' work in any external press, publications, websites, social media and/ or in any promotional material connected to this competition.
