STATUTE CCCXIX

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Given under the Common Seal of National University of Ireland, Galway, this sixteenth Day of December, Two Thousand and Ten.

Schedule - STATUTE CCCXIX

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

PERSONAL PROFESSORSHIPS

1. There are hereby established in the University the following Personal Professorships:

Personal Professorship (No. 3) of English Personal Professorship (Part-time) of Economics.

- 2. The annual stipend attaching to the foregoing Personal Professorship of English shall be the same as that attaching from time to time to the fulltime Personal Professorships of the University.
- 3. The annual stipend attaching to the foregoing Personal Professorship (Part-time) of Economics shall be one-half of that attaching from time to time to the fulltime Personal Professorships of the University.
- 4. Each of the said Personal Professorships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 5. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of each of the said Personal Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a "new entrant" to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of each of the said Personal Professorships shall not be entitled to retire before attaining the age of sixty-five years.
- 6. The holder of each of the said Personal Professorships shall carry out the duties of the Personal Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER II

CHANGE OF TITLE

1. The Senior Lectureship in Clinical Pharmacology shall henceforth be known as the Senior Lectureship in Therapeutics.

- 2. Statute CCCVIII, Chapter II, Section 5, Subsections (a) and (b) is hereby amended as follows:
 - "(a) The holder of the foregoing Senior Lectureship in Therapeutics shall be required to be at the same time the holder in a permanent capacity of an office of Consultant Physician to be established in conjunction with the said Senior Lectureship by the Health Service Executive in University Hospital Galway/Merlin Park University Hospital Galway. In the event that the holder of the Senior Lectureship ceases to hold the said office of Consultant Physician, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.
 - (b) The holder of the said Senior Lectureship shall devote one-half of his/her time to the duties of the said Senior Lectureship and one-half of his/her time to the duties of the foregoing office of Consultant Physician."

CHAPTER III

- 1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
- 2. This Statute shall come into operation on the sixteenth day of December, Two Thousand and Ten, and may be cited as Statute CCCXIX, National University of Ireland, Galway, or Stat. CCCXIX, Nat. Univ. of I., Galway.
