STATUTE CCCXXIII

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Schedule - STATUTE CCCXXIII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ESTABLISHED PROFESSORSHIP

1. There is hereby established in the University the following Established Professorship:

Established Professorship of Vascular Surgery.

2. The holder of the Established Professorship of Vascular Surgery shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Cardiovascular Surgeon to be established in conjunction with the said Established Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the said Established Professorship ceases to hold the said office of Consultant Vascular Surgeon, (s)he shall thereby be deemed to have resigned from the said Established Professorship.
3. The holder of the Established Professorship of Vascular Surgery shall devote one-half of his/her time to the duties of the said Established Professorship and one-half of his/her time to the duties of the foregoing office of Consultant Vascular Surgeon.
4. The annual stipend attaching to the foregoing Established Professorship shall be one half of the salary attaching from time to time to joint fulltime Academic Medical Established Professorship appointments.
5. The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
6. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, be entitled to continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a "new entrant" to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of the said Established Professorship shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years.
7. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of such Head of the School as Údarás na hOllscoile shall from time to time deem appropriate.

8. The holder of the foregoing Established Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council shall prescribe, subject to review by Údarás na hOllscoile.

CHAPTER II

PERSONAL PROFESSORSHIP

1. There is hereby established in the University the following Personal Professorship:

Personal Professorship of Management.

2. The annual stipend attaching to the foregoing Personal Professorship shall be the same as that attaching from time to time to the fulltime Personal Professorships of the University.
3. The said Personal Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. Subject to the terms of the Employment Control Framework currently in operation in the University, under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, be entitled to continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a "new entrant" to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of the said Personal Professorship shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years.
5. The holder of the said Personal Professorship shall carry out the duties of the Personal Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.

2. This Statute shall come into operation on the fourteenth day of October, Two Thousand and Eleven, and may be cited as Statute CCCXXIII, National University of Ireland, Galway, or Stat. CCCXXIII, Nat. Univ. of I., Galway.
