STATUTE CCXCVIII

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by the of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Schedule - STATUTE CCXCVIII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ESTABLISHED PROFESSORSHIP OF MOLECULAR MEDICINE

1. There is hereby established in the University the following fulltime Established Professorship:

Established Professorship of Molecular Medicine.

- 2. The annual stipend attaching to the foregoing Established Professorship shall be the same as that attaching from time to time to the fulltime Established Professorships of the University.
- 3. The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 4. The holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- 5. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of the Head of the Department of Medicine.

CHAPTER II

ESTABLISHED PROFESSORSHIP OF IMMUNOLOGY

There is hereby established in the University the following Established Professorship:

Established Professorship of Immunology.

- 2. The holder of the foregoing Established Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Physician to be established in conjunction with the said Established Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the Established Professorship ceases to hold the said office of Consultant Physician,, (s)he shall thereby be deemed to have resigned from the said Established Professorship.
- 3. The holder of the said Established Professorship shall devote eight-elevenths of his / her time to the duties of the said Established Professorship and three-

elevenths of his/her time to the duties of the foregoing office of Consultant Physician.

- 4. The annual stipend attaching to the said Established Professorship shall be eight-elevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Professor appointments.
- 5. The holder of the said Established Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
- 6. The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 7. The holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- 8. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of the Head of the Department of Medicine.

CHAPTER III

PERSONAL PROFESSORSHIP OF OTOLARYNOLOGY

1. There is hereby established in the University the following Personal Professorship:

Personal Professorship of Otolarynology.

2. The holder of the foregoing Personal Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Otolaryngologist to be established in conjunction with the said Personal Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the Personal Professorship ceases to hold the said office of Consultant Otolaryngologist, (s)he shall thereby be deemed to have resigned from the said Personal Professorship.

The holder of the said Personal Professorship shall devote three-elevenths of his/her time to the duties of the said Personal Professorship and eight-elevenths of his/her time to the duties of the foregoing office of Consultant Otolaryngologist.

The annual stipend attaching to the said Personal Professorship shall be threeelevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Associate Professor appointments.

The holder of the said Personal Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.

The said Personal Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.

The holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.

The holder of the said Personal Professorship shall carry out the duties of the Personal Professorship under the direction of the Head of the Department of Surgery.

CHAPTER IV

SENIOR LECTURESHIPS (UNTITLED)

There are hereby established in the University the following fulltime Senior Lectureships:

Senior Lectureship (Untitled) No. 53 Senior Lectureship (Untitled) No. 54

Senior Lectureship (Untitled) No. 55

Senior Lectureship (Untitled) No. 56

Senior Lectureship (Untitled) No. 57.

The annual stipend attaching to each of the foregoing Senior Lectureships (Untitled) shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.

Each of the said Senior Lectureships (Untitled) shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.

The holder of each of the said Senior Lectureships (Untitled) shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.

The foregoing Senior Lectureships (Untitled) shall be established in the Faculties and in the subjects as Údarás na hOllscoile shall decide from time to time.

The holder of each of the said Senior Lectureships (Untitled) shall carry out the duties of the Senior Lectureship under the direction of such Head of Department as Údarás na hOllscoile shall deem appropriate.

CHAPTER V

Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.

This Statute shall come into operation on the twentieth day of October, Two Thousand and Six, and may be cited as Statute CCXCVIII, National University of Ireland, Galway, or Stat. CCXCVIII, Nat. Univ. of I., Galway.
